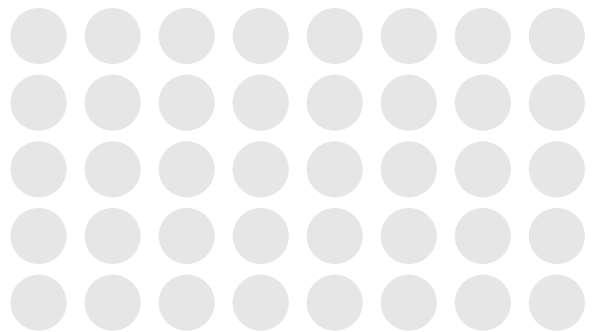

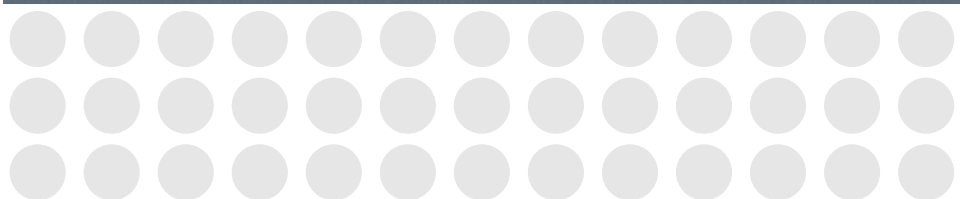


## Coverage
